甲乙双方本着“安全第一、预防为主、综合治理”的方针，切实保障安全生产，保障从业人员生命财产安全。本着平等互利，互帮互助的原则，通过甲乙双方友好协商，达成此应急救援协议。

二、甲方职责

- 1、向乙方提供发生事故所在地的详细位置、联系电话、联系人及有效的通讯工具。
- 2、发生事故后及时拨打乙方电话，说明发生的时间、地点、人员及伤亡情况。
- 3、协助乙方做好应急救援的准备工作。
- 4、确保乙方在救援现场人身安全防护措施，确保乙方救护人员的人身安全。
- 5、发生事故救援完成后，甲方应及时将救援器材、物资归还乙方，造成损失和消耗的，甲方应对乙方做一定的经济补偿。

三、乙方职责

- 1、接到甲方通知后按具体情况做好救援准备。

3、根据甲方需要，经双方协商，每年进行一到两次消防演练，以提高双方应尽处理能力。

4、因受客观因素影响的，双方应协商解决。
